# **EVLT TREATMENT INFORMATION**

# Before you check-in for your EVLT:

#### Please arrive at your assigned time of:

- We ask that you stop eating and drinking any fluid at midnight the night before your treatment.
- We are located on the third floor across from the Physical Therapy Department and The Spine Center close to Elevator C.
- You will be at our facility for three to four hours.
- You will need a ride home due to the medication you will receive during the treatment.
- Please do not shave your legs for two days before your scheduled treatment.

# After procedure information:

#### • When may I return to normal activities?

The initial few hours after returning home from Valley View you may feel like resting but we would like to see you up walking as much as tolerated the first day. You may return to work & your normal activities as you feel like it.

#### • How will I feel after the EVLT?

You may feel tired due to the sedation this will improve within the first few hours after your treatment. You may have pain in your legs that Tylenol will help with. You will leave Valley View with a prescription for pain medication and you may need a few pain tablets for the first two days following treatment. You may return to work the day after your treatment but please listen to your body and take it easy if you need to.

#### • Hydration

Water is good for you and after the EVLT treatment your body needs to stay hydrated. Please consume six to eight glasses of water a day.

• Food

Please eat healthy well balanced foods as your body desires.

#### • Wound care

You have a small puncture wound that is covered by a band aid. With clean hands you may remove the band aid on the morning after your EVLT.

#### • Compression stockings

Please remove your wrapped bandages the night of your EVLT just before you are in bed for the night. Please apply your compression stockings in the morning after your EVLT while you are still in bed. This will ensure that your veins are not challenged by the changes your veins experience when you stand up.

#### • When will my veins fully recover?

It may take up to six months for your veins to fully soften. Please continue to wear your compression stockings during this time for this will assist in the process.

#### • When to call my doctor?

If you start running a fever over 101.5 degrees or notice increased pain, redness or drainage coming from your wound.

### About varicose veins:
